Crooked Hill Road Update

Renee Edwards read aloud correspondence received from Brian C. Curtis, Town Engineer, stating that he spoke with Brian Ferris and asked him about the current status of the Northern Heights subdivision in Guilford and plans for reconstruction of Crooked Hill Road in Durham. Mr. Ferris indicated he is still planning to proceed with the project this spring but he is still working on finalizing financing for the project and it is taking him a little longer than expected. Mr. Ferris said that he would get back in touch with him once the project financial arrangements have been finalized.

Old/New Business

Renee Edwards read correspondence from the Public Safety Committee received from Susan Viccaro, Superintendent of Schools in reference to a question the Public Safety Committee posed about the Mica Hill school bus route. Ms. Viccaro stated that in discussions with Dattco, Regional District 13 school buses should avoid the use of Crooked Hill Road at anytime. Mica Hill, although narrow at the S-curve is still the safer choice for coming in as well as going out.

Renee Edwards discussed a letter received from the Durham/Middlefield Exchange Club dated January 17, 2007 stating they were conducting a search for a recipient of their Book of Golden Deeds Award. Renee stated that she had someone in mind, Maryann Boord agreed. Renee asked that this be acted upon quickly as the correspondence needed for nomination has to be sent in by February 10, 2007.

Renee Edwards stated that she would like the Board of Selectmen to take a look at the new town charter to see what changes affect the Board of Selectmen so they can discuss. Two issues that she was aware of were the formation of an ethics committee and town acquisition policy. Beth Moncata stated that she thought Finance Director, Maryjane Malavasi had done some research already on an acquisition policy. Renee Edwards suggested that Maryjane Malavasi attend the next Board of Selectmen's meeting to bring them up to date with her research.

Maryann Boord stated that the Regional Health District Exploratory Committee has made no final choice yet and the committee is asking for an extension of time. The two final districts have requested that they have that the committee meet with the directors.

Selectmen's Comments

Maryann Boord stated that State Representative, Raymond Kalinowski introduced a bill to name a portion of Route 17 to the Guilford town line to Charles Wimler. She suggested that the First Selectmen draft a letter of support and present it at the next Board of Selectmen's meeting.

Renee Edwards commended Ellen Mauro and the Public Works Employees for doing a good job preparing for the Wimler funeral services.

Maryann Boord commented on an email that she received from Attorney George O'Brien, Town Counsel stating that he will be leaving the employment of Tyler Cooper, and asked the question of how this would affect the Town of Durham. Renee Edwards commented that Attorney O'Brien had assured her that the transition will be effortless on the town's part and that key people within the firm who have already been working with the town will continue to do so.
